Liste VI - Sri Lanka

Le représentant permanent de Sri Lanka a fait parvenir au secrétariat la communication suivante.

J'ai l'honneur de vous remettre, aux fins de certification, une Liste codifiée VI - Sri Lanka mise à jour.

La nouvelle liste codifiée reprend les résultats des renégociations au titre de l'article XXVIII:1 récemment achevées, qui figurent dans les documents SECRET/247/Add.1 à 3. La liste contient également les modifications du tarif autorisées par la dérogation du 21 mai 1971 (cf. IBDD, Supplément n° 18, page 31 et document L/3486/Add.1) et reprend en outre des modifications des droits de douane effectuées en 1977 en relation avec les mesures prises pour libéraliser le commerce extérieur de Sri Lanka et rationaliser son tarif douanier (cf. document MTN/19).

Si aucune objection n'est notifiée au secrétariat dans un délai de 60 jours à compter de la date du présent document, la nouvelle Liste VI - Sri Lanka - dans laquelle la colonne "Taux actuel" contient les taux qui seront consolidés dans le cadre de l'Accord général - sera considérée comme approuvée et sera incorporée dans la Cinquième Certification de changements apportés aux listes.
