RESTRICTIONS ON IMPORTS FROM ROMANIA

Notifications by Contracting Parties

Addendum

1. Thirteen notifications of restrictions on imports from Romania were circulated in document L/4935 dated 13 February 1980.
2. Five further notifications were circulated in document L/4935/Add.1 dated 19 February 1980.
3. The following notifications have been received from Barbados and Sweden.
4. Contracting parties which have not yet submitted notifications are invited to do so without delay.

BARBADOS

I have the honour to refer to your airgram GATT/AIR/1596 of 21 December 1979 on the subject of restrictions of imports from Romania and wish to inform you that on 1 January 1980 Barbados did not have any discriminatory prohibitions or restrictions on imports from Romania.

SWEDEN

With reference to GATT/AIR/1596 of 21 December 1979, I have the honour to submit a list of products which are subject to restrictions when imported into Sweden from Romania.

The quotas for 1980 have been increased for the majority of the items subject to quantitative restrictions.
