FIFTH CERTIFICATION OF CHANGES TO SCHEDULES

Schedule LXXII - European Economic Community

The following paragraph should be added to document L/4949 which was circulated on 29 February 1980:

"If no objection is notified to the secretariat within sixty days from the date of the above-mentioned document, the rectifications to Schedule LXXII - European Economic Community will be deemed to be approved and will be included in the Fifth Certification of Changes to Schedules."

In addition, the communication reproduced in the Annexes hereto, has been received from the Commission of the European Communities.

If no objection is notified to the secretariat within sixty days from the date of the present document, the references to Units of Account (UA) in Schedule LXXII - European Economic Community will be considered to have been changed into European Units of Account (EUA) as indicated in the annexed communication and a note to this effect will be included in the Fifth Certification of Changes to Schedules.

ANNEX I

1. In an Information Note of 4 October 1978, circulated under the reference L/4706, the European Communities informed the Contracting Parties of the adoption of the European Unit of Account for the Common Customs Tariff. Detailed explanations were given in that note and consultations were held with the Contracting Parties who stated their desire to do so.
2. The European Communities subsequently expressed in EUA the specific elements in their schedules of concessions annexed to the June 1979 Protocol of Geneva.
3. The European Communities wish to notify, in accordance with the decision of the Contracting Parties of 19 November 1968, on the procedures for rectifications and modifications, that the adoption of EUA applies not only to the concessions resulting from the Tokyo Round but also to all bound positions of the Schedules of Concessions LXXII which include a specific element formerly expressed in UA.<sup>1</sup>
4. Accordingly, the term UA or Unit of Account should be replaced by EUA or European Unit of Account for those positions.
5. The complete list of the positions concerned is annexed (including those given in the Tokyo Round denoted by the initials TR). It is divided in two columns. The "duty" column shows headings concerned with specific duties. The "description" column shows headings concerned with EUA in the description of products.
