## IMPORT LICENSING REGIME

Peru<sup>1</sup>

The following communication, dated 15 October 1980, has been received from the Permanent Mission of Peru.

- 
1. Goods subject to prior import licensing appear in the annexed list in the order of the tariff headings of the CCCN.
  2. A prior import licence is an indispensable requirement, which must be complied with, for the import of goods subject to restriction.
  3. Types of restriction. The following symbols are used in the Schedule:  
P = prohibited import.  
L = subject to licensing.
