Addendum

With reference to the Enabling Clause, the delegation of the United States has provided the following information regarding changes made in the United States GSP scheme applied as of 31 March 1982.

1. Changes Resulting from the 1981 GSP Product Review

The addition of new products to the GSP list.--As a result of the annual product review, 48 new items are being designated for GSP duty-free treatment as of March 31, 1982. These items represent \$76 million in newly-eligible trade, compared to the \$442 million added in last year's review. The remaining 38 petitions under consideration in this year's review were denied, in most instances because of the import sensitivity of the domestic industry. (See Annex I and Table 1).

The removal, or "graduation," of a country from eligibility with respect to individual products.--Four countries, Taiwan, Singapore, Korea and Israel, will be graduated from GSP eligibility on certain products in response to petitions filed by U.S. producers or labor unions. The graduation actions affect eight of 16 requests for limitation of GSP benefits under review, with excluded trade valued at \$54 million, compared to the \$87 million similarly excluded last year. (See Annex II and Table 2).

The removal of items from the GSP.--No decision has been reached with respect to the three headwear items under review (TSUS items 702.25, 702.28, and 702.30). The U.S. International Trade Commission is conducting an investigation under section 332 of the Tariff Act of 1930 to obtain additional information pursuant to a USTR request.

2. Other Modifications

Redesignation of individual beneficiary developing countries for GSP benefits on specific items.--Individual countries previously excluded from receiving GSP duty-free treatment for particular products may be redesignated for GSP benefits if their 1981 shipments in individual items fell below last year's competitive need limits. Under this provision developing countries are being redesignated for GSP duty-free treatment on 35 products valued at \$213 million, which represents 26 percent of the total amount of trade eligible for redesignation. The remaining 74 percent, or 35 items valued at \$597 million, are being graduated and thus are not being redesignated. In last year's redesignation exercise, imports valued at \$152 million were restored to GSP eligibility while \$356 million of beneficiary country trade was denied reinstatement. (See Annex III and Table 3).

De minimis exemptions from the 50 percent competitive need provision.--A de minimis provision in the Trade Agreements Act of 1979 allows the President to waive the 50 percent competitive need limit in cases where total U.S. imports of an item in 1981 did not exceed \$1,210,572. As a result of the de minimis provision, imports of 194 products valued at \$41 million from individual beneficiaries will be exempt from the 50 percent competitive need rule. The value of trade benefiting from this provision last year was \$38 million. (See Annex IV and Table 4).

The exclusion of exports of individual countries from GSP duty-free treatment for certain products because the competitive need ceilings were exceeded.--Under the statutory competitive need provisions, a country loses GSP duty-free treatment for a product if its shipments of the product in the preceding calendar year equaled or exceeded 50 percent of total U.S. imports of the product or were more than a certain dollar value (\$50.9 million for imports in 1981). Competitive need exclusions total approximately \$6.8 billion based on 1981 trade, as compared to the \$5.6 billion affected by the statutory exclusions last year. (See Annex V and Table 5).

3. Designation of CARICOM as a Regional Association for Purposes of GSP

An association of developing countries found to be contributing to regional economic integration through certain actions, including but not limited to the reduction of tariffs among its members, may be designated as eligible to receive cumulative treatment under the rules of origin of the U.S. GSP. Cumulative treatment allows two or more member countries of an association to combine processing operations in order to meet the 35 percent value-added requirement of the U.S. GSP. The Caribbean Common Market (CARICOM) will be designated for such cumulation effective March 31, 1982. The association's members are Antigua and Barbuda, Barbados, Belize, Dominica, Grenada, Guyana, Jamaica, Montserrat, Saint Christopher-Nevis, Saint Lucia, Saint Vincent and the Grenadines, and Trinidad and Tobago. Two other associations--the Andean Group and ASEAN--received similar designations last year.
