## ARTICLE XIX - ACTION BY CANADA

### Footwear

#### Notification of Compensatory Measures by the European Economic Community

#### Addendum

The following communication, dated 27 February 1985, has been received from the delegation of the European Communities.

Document L/5351/Add.17 of 7 June 1984 announced the Canadian Government's decision, in pursuance of Article XIX, to extend for sixteen months from 30 November 1984 quotas on imports of leather and non-leather footwear including canvas footwear. Thereafter, the Canadian Government advised contracting parties (cf. L/5263/Add.19 of 21 December 1984) of changes in the implementation of the measures on non-leather footwear (the extension of the quota had been shortened to twelve months, and its level had been raised by 4.1 per cent).

The EEC has had consultations with Canada under Article XIX, without any agreement being reached regarding these measures.

In these circumstances, and unless further consultations with Canada result in a mutually satisfactory agreement in the near future, the European Communities find themselves obliged to take compensatory measures in pursuance of Article XIX:3(a).

Consequently, in accordance with the procedures laid down by those provisions, the European Communities are hereby giving thirty day's notice in writing of their intention to suspend the application of substantially equivalent concessions on trade in certain products originating in Canada.

These compensatory measures will be applicable for a period of one year and will take effect on 1 April 1985 at the earliest. Annexed to the present notification is the list of products affected by this action.

EC WITHDRAWAL OF CONCESSIONS

In addition to a total import ban on Canadian footwear (NIMEXE positions 6401.11 to 6405.98), imports of which accounted for an average 4 606 000 ECU during the period 1981 to 1983, the following products will be subject to an increase in duty

<sup>1</sup>The trade loss suffered by the Community on the Canadian footwear market by reason of the prolongation of import restrictions from 1 December 1984 to 30 November 1985 has been calculated on the basis of average Canadian imports from the EC over the period 1975-77 (the three recent years prior to the restrictions), and a potential rate of increase of 2 per cent in Community footwear exports to the Canadian market. The trade loss amounts to 3.7 million pairs representing, on the basis of an average price of \$Can 15.76 (Canadian figure) a trade loss of \$Can 58.3 million.
