PROMOTION OF EXTERNAL ECONOMIC POLICIES OF THE
JAPANESE GOVERNMENT INCLUDING TARIFF CHANGES IN F.Y. 1983

The following communication, dated 25 January 1983, has been transmitted by the Representative of Japan to the Director-General.

With reference to my letters addressed to you dated 10 and 13 January 1983, I have the pleasure in enclosing a document entitled "On the Promotion of External Economic Policies" (Annex 1), decided on by our Ministerial Conference for Economic Measures, 13 January 1983.

I also enclose another document entitled "The Tariff Changes in F.Y. 1983" (Annex 2), which sets forth the tariff reductions measures decided on by the Ministerial Conference mentioned above which will come into effect on 1 April 1983 together with the 215 items which were included in the market-opening measures announced in May 1982 and which will also benefit from tariff reductions.

ANNEX 1

On The Promotion of External Economic Policies

13 January 1983

Ministerial Conference For Economic Measures

In light of the recent world economic situation, Japan has decided upon and enacted a wide range of external economic policies since 1981, including the various market-opening measures, in an effort to preserve the free trading system and to promote global economic development through expansion of trade in a balanced manner. The Ministries and Agencies concerned and the Special Committee for International Economic Measures of the Liberal Democratic Party have co-operated in the formulation of these new measures to accomplish the continued further opening of the market.

As a result of this study, the following policies have been drawn up and will be implemented.

1. Reduction of tariff rates

Tariff rates will be reduced or eliminated effective as of fiscal 1983 on items of concern to foreign countries such as tobacco products, chocolate, biscuits, and forty-seven agricultural products and twenty-eight manufactured products.

These measures bring to 323 the total number of items on which tariff rates will be reduced or eliminated in fiscal 1983, including the 215 items which were included in the market-opening measures announced in May 1982 (see L/5332).

2. Relaxation of import restrictions

Import restrictions will be relaxed on dried leguminous vegetables, groundnuts, fruit purée and paste, non-citrus fruit juice, tomatoe juice, and tomato ketchup and sauce.

3. Improvement of import testing procedures, etc.

A. Setting-up of an OTO Advisory Council

An OTO Advisory Council shall be set up (See Appendix 1) to provide advice and suggestions on every aspect of activities of the Office of Trade Ombudsman (OTO) and to support its activities.

B. Strengthening of the functions of OTO

Along with instituting a new system allowing the filing of complaints by proxy, the strengthening of OTO's liaison and co-ordinating functions, and the improvement of complaints processing procedures in the Ministries and Agencies concerned, the Regional Liaison Committees will be expanded and other measures taken to enhance the capability of the OTO to respond to complaints. Moreover availability of the OTO will be publicized more widely, and efforts will be made to ensure expeditious communication with all interested parties.

C. Improvement of standard and certification systems, etc.

A comprehensive review of standards and certification systems, etc. which may lead to revision and amendment of laws and regulations concerned will be conducted with a completion target of the end of March this year with a view to further opening up of the market. For this purpose, a Liaison and Co-ordinating Headquarters headed by the Chief Cabinet Secretary and comprising Ministries and Agencies concerned will be established within the Japanese Government.

D. Improvement of import testing procedures, etc.

Further improvement of import testing procedures, etc. will be made as described in Appendix 2.

E. Ministerial-level responsiveness

Opportunities will be provided for the exchanges of views between Ministers and diplomatic missions, etc. in Japan to deepen mutual understanding and to assist prompt solution of the problems.

F. Strengthening of administrative inspection

Administrative inspection will be strengthened so as to ensure a more thorough improvement of import testing procedures and other issues handled by the OTO.

4. Import promotion

A. Further promotion of distribution for foreign tobacco products

(a) Expansion of the number of outlets handling imported tobacco products

I. This expansion will be realized by the end of March 1983 for all outlets wishing to handle imported tobacco products in Nagoya and other major cities except the Tokyo and Osaka areas.

II. A further expansion will be made by the end of October 1983 to all outlets wishing to handle imported tobacco products in the Tokyo and Osaka areas.

III. With regard to the expansion of outlets to all areas other than I and II above, efforts will be made to expedite part of its implementation by the end of fiscal 1984 instead of original target of the end of fiscal 1985. It is requested that the Japan Tobacco and Salt Public Corporation and United States manufacturers concerned meet soon to discuss and to work out the details of this implementation.

(b) Distribution for imported tobacco products

Distribution systems of imported tobacco products will be studied in tandem when the issue of the restructuring of the Japan Tobacco And Salt Public Corporation be dealt with in the future by monitoring the views of the parties concerned in Japan along with the studies on the distribution systems and of the budgetary revenue system.

B. Expansion of the import of manufactured products, etc.

(a) Improvement will be made in light of the analysis of the actual situation and the views expressed by the foreign entities and individuals concerned at the Trade Conference (Committee For Manufactured Goods Import Measures) regarding the distribution system and Japanese business practices.

(b) In addition to promoting the further utilization of the business consultant service system, co-operation will be extended to activities such as study on potential new import products in the Japan Foreign Trade Council's Import Promotion Council.

5. Other measures

A. Export policy

In line with the basic aim of expansion of trade in a balanced manner, efforts will continue to be made to avoid excessive concentration of exports in specific product categories.

B. Industrial co-operation

In order to revitalize the world economy, such forms of industrial co-operation as mutual investment, technological co-operation, and joint projects in third markets will be actively encouraged.

C. Government procurement

The procurement of goods by Government agencies and organizations will continue to be effected properly in accordance with the Government Procurement Code.

Further, concerning the procurement by the NTT, as part of the continued sincere implementation of internationally non-discriminatory and competitive procurement procedures, measures will continue to be actively taken to publicize information concerning the procedures and other aspects of procurement and to respond readily to those foreign companies wishing to participate in the NTT procurement, so as to facilitate their participation.

APPENDIX 1

OTO Advisory Council

The OTO Advisory Council (hereinafter referred to as the Council) shall conduct its meetings in accordance with the following in order to contribute to the further opening of the Japanese market.

1. The Council shall, on the basis of reports from the OTO, deliberate on the following matters and, as appropriate, give advisory opinions to the Government:
 - A. Matters relating to the operating policy of the OTO and the overall state of OTO activities.
 - B. Matters relating to systems which gave rise to specific complaints.
 - C. Matters relating to important specific complaints especially those on which complaints have been refiled.
 - D. Matters relating to import testing procedures and other problems of market access.
2. The Council shall be composed of not more than eight members including persons who are well-versed in the international economy and trade.
3. The Council shall have one chairman selected by and from its members.
4. The Council shall be convened as necessary. The Council may invite to its meetings members of the OTO Headquarters, people with academic or professional expertise, complainants, and other parties concerned both Japanese and foreign, to hear their reports or views.
5. Logistic support for the Council shall be provided by the Coordination Bureau, Economic Planning Agency.

APPENDIX 2

Improvement of Import Testing Procedures

Details of measures

1. Additions to the list of already approved ingredients of cosmetics

At present, 1,000 permissible ingredients have been published. In addition, approximately 800 more will be published. The list of ingredients to be added has already been presented to the United States and the European Community in November 1982.

2. Approval of consumer preference tests on non-approved cosmetics

Consumer preference tests will be allowed to be given on those cosmetics not yet being approved within certain extent, from April 1983.

3. Simplification of procedures for the transfer of approvals for imports among enterprises

Procedures for the transfer of approvals for imported pharmaceuticals will be substantially simplified after April 1983 by elimination of submission of such testing data as was already appended in the previous authorization.

4. Revision of JAS standards for plywood knots, adhesive strength, etc. and white pockets

(1) Revision of standards concerning knots and adhesive strength was made after the prior procedures based upon GATT Standards Code and will be implemented from 14 January 1983;

(2) Results of the tests on white pockets will be submitted to the Japan - United States Forestry Products Committee whose meeting is scheduled to be held on 24 and 25 January 1983. Future revisions of JAS standards will be studied by the Agricultural and Forestry Products Standards Council.

5. Acceptance of foreign test data on animal pharmaceuticals

Foreign test data on drug stability and toxicity have been accepted since 1 June 1982.

6. Acceptance of foreign test data for feed additives

Foreign test data on stability and toxicity are already accepted and steps are being taken to accept foreign test data on basic tests endorsing effectiveness from the beginning of February 1983.

7. Acceptance of foreign inspection data on high-pressure gas containers

The High Pressure Gas Safety Association (HPGSA), the Containers Testing Organization under the High Pressure Gas Control Law, has decided to accept test data of foreign testing organization by commissioning and inspection contract. The HPGSA is finalizing such a contract with an Australian inspection organization to be completed by February 1983, and is ready to utilize the scheme with other foreign inspection organizations.

8. Simplification of import procedures for aerosol products

A ministerial notification will be issued toward January 1983 to simplify import procedures for aerosol products, by reducing test requirements for continuous imports of small quantity imports.

9. Making the S mark and SG mark on consumer products available to overseas manufacturers

1. To facilitate the resolution of the problem of metallic bats, these bats were excluded from the scope of the Consumer Products Safety Law, effective 6 January 1983. Adjustments with the parties concerned to allow manufacturers overseas to enjoy advantages substantially equivalent to those enjoyed by Japanese manufacturers under the S mark system are in progress.

2. Overseas manufacturers will be given access to the SG mark system operated by the Product Safety Association before the end of January 1983.

10. Adjusting technical standards for electric appliances and materials to be brought in line with international standards

Efforts to revise the technical standards for electric appliances including home electric appliances will continue toward the end of FY 1983 in order to make the standards under the Electrical Appliance and Material Control Law consistent with the IEC Standards.

11. Acceptance of foreign inspection data for electric appliances

The Japan Electric Testing Laboratory set up a scheme to mutually accept data by conducting a contract with United States and Canadian inspection organizations in December 1982. Similar scheme will be considered for other foreign inspection organizations which request such treatment.

12. Participation of foreign manufacturers of air conditioners in the private level inspection system

The Japan Refrigeration and Air Conditioning Industry Association is in the process of adjusting the procedures for the testing of room air-conditioners to ensure that room air-conditioners manufactured overseas qualify for its testing system. The target date is the end of February 1983.

13. Expansion of the number of cars entitled to apply for a simplified examination procedures as a small-quantity motor vehicles

Limitation of the number of the motor vehicles which are entitled to apply for a simplified handling as a small-quantity motor vehicle will be expanded from the current level of 100 units to the level of 300 units as of March 1983.

14. Active participation in the work of international harmonization of automotive standards

Active participation in the activities for international harmonization of automotive standards by the experts group on the construction of vehicles of the UN Economic Commission for Europe is being carried out.

15. Designation of additional foreign official testing institutions for foreign automobiles (in addition to the already designated nine institutions)

Foreign official inspection institutions wishing to have their inspection results accepted will be further designated promptly after the necessary checking procedures.

16. Acceptance of the certification by the designated foreign notary public of dates of manufacture for imported automobiles

In addition to the acceptance of manufacture date certified by official organs in European Community countries and Sweden, measure has been taken as of November 1982 to accept the certification by the United States notary public of the date of manufacture of the motor vehicles. Future application for the same procedure by other countries will be accepted after necessary checking procedures.

ANNEX 2
Tariff Changes in F.Y. 1983

The Customs Tariff Council submitted to the Minister of Finance a recommendation on Tariff Changes in F.Y. 1983 on 24th December 1982.

These tariff changes are expected to become effective as from April 1, 1983 subject to the approval by the Japanese Diet.

The outline of the tariff changes is as follows :

Note 1

Economic measures to open up the Japanese market taken at Ministerial Conference for Economic Measures :

May 28, 1982 : Elimination or reduction of tariff rates on 215 items

January 13, 1983 : Elimination or reduction of 47 agricultural products and 28 industrial products in addition to tobacco, chocolates and biscuits.

Note 2

Although in principle agricultural products are classified in CCCN1-24 and industrial products are classified in CCCN25-99, two protein products (tariff item No. 35.04-3.ex) are classified here agricultural products.
