## Communication from the United States

The following communication, dated 31 March 1983, has been received from the United States Trade Representative.

I am writing to request, pursuant to the Ministerial Decision on Services, concerning exchanges of information on services, that the attached outline of a proposed United States study on services be distributed to contracting parties for their information. My delegation would, of course, welcome any comments that other delegations may wish to make concerning this outline.
