Communication from Brazil

The following communication, dated 6 October 1983, has been received from the Permanent Delegation of Brazil.

I have the honour to submit herewith a copy of Communiqué No. 41, issued by the Foreign Trade Department of the Bank of Brazil (CACEX), which enlists products which are subject to special import licensing requirements. This notification is done in accordance with paragraph 3 of the Understanding Regarding Notification, Consultation, Dispute Settlement and Surveillance.

1. The FOREIGN TRADE DEPARTMENT (CACEX) of the Bank of Brazil S.A., having considered the recommendations of the Special Secretariat for Data Processing (SEI); having considered Decree Laws No. 84,067 of 8 October 1979 and No. 85,790 of 6 March 1981, in Section II of Decision No. 121 of 7 December 1979 of the National Foreign Trade Council (CONCEX) and in Normative Law SEI/CDI No. 001/82 of 17 February 1982 published in the Official Gazette of the Union on 18 February 1982; hereby announces the issue of licences for importation of the goods listed below. The issue of such licences is subject to prior and express authorization by the Special Secretariat for Data Processing given in the form and by the procedures specified in paragraph 133 of CACEX Communiqué No. 7 of 4 March 1982 and in Section I of CACEX Communiqué No. 13 of 4 June 1982.

2. The SEI must give prior and express authorization for imports of machines, equipment, apparatus and instruments, either separate or forming systems, which, although falling under a tariff heading not requiring examination by the SEI, or not falling under any specific tariff heading, comprise, incorporated or as accessories, controls, monitors or other systems having digital logic circuits of the numerical control type, programmable logic control or the like.

2.1 Import licences for products falling under this paragraph must specify, clearly and separately, the electronic module or modules incorporated and their individual value.

3. The above list replaces that in Section I of the Decision No. 121 of 17 February 1979 of the National Foreign Trade Council.

4. CACEX Communiqué No. 10 of 13 April 1982 is thus cancelled.
