JAPAN - TARIFF CHANGES IN FISCAL YEAR 1984

The following communication, dated 18 April 1984, has been received from the Permanent Mission of Japan.

The Japanese tariff changes in FY 1984 consist of a total number of items of 1,327 on which tariff rates are reduced or eliminated and amendments to the GSP scheme which were included in Comprehensive Economic Measures announced in October 1983.

These tariff changes become effective as from 1 April 1984. The outline of the tariff changes is as follows:

- 1. Advanced tariff reductions on industrial products agreed upon in the MTN Tokyo Round (1,280 items)
 - (1) With respect to the scheduled tariff reductions on industrial products agreed upon in the MTN Tokyo Round, it is recommended that the remaining three-year cuts be accelerated in FY 1984 and FY 1985 and that the one-year advanced cut be implemented in FY 1984.
 - (2) Concrete measures to be taken in FY 1985 will be decided, taking into account the advanced implementation of MTN tariff reductions in the major industrialized countries.

2. Amendments to the GSP scheme

- (1) Increase in the total ceiling quotas for industrial products. Total ceiling quotas for industrial products have been increased by about 55 per cent (FY 1984 ¥ 1,220 billion, US\$5.2 billion; FY 1983 ¥ 785 billion, US\$3.3 billion) through amendment of the calculation formula on ceilings as mentioned below:
 - (a) Regarding those items which are considered to involve no particular difficulties on the part of the domestic industries concerned, the calculation formula on the ceiling quotas is to be revised to the "CY 1982 basic formula".

The list of these items is available for consultation in the secretariat (Ms. Y. Davel, Tariff Division, office 1025, ext. 2156).

- (b) Regarding those items on which the application of the "CY 1982 basic formula" entails difficulties, one of the following formulae is to be applied depending on the situation of the domestic industries concerned.
 - (i) /Ceiling quota of the previous FY/ + /ceiling quota of the previous FY/ \times /specified rate /
 - (ii) / $\overline{Ceiling}$ quota of the previous \overline{FY} + / $\overline{Ceiling}$ quota of the previous \overline{FY} x / $\overline{Specified}$ rate/ x $\frac{1}{2}$
 - (iii) \overline{C} eiling quota of the previous \overline{FY}

However, as a temporary measure, ceiling quotas for FY 1984 are to be set at the levels of 1.5, 1.3 or 1.1 times of the ceiling quotas for FY 1983.

- (2) Measure to extend the benefits of GSP to more developing countries. In order to extend the benefits of GSP to a greater number of developing countries, the "maximum country amount" is revised to be one third of the ceiling quota instead of one half of the ceiling quota. However, the revised level of the "maximum country amount" is to be not lower than one half of the ceiling quota in FY 1983 with respect to each item.
- (3) Revision of Special Measures for the Least-Developed Countries.
 - (a) With respect to woven fabrics of jute (CCCN tariff heading No. 57.10), a special tariff rate for LLDCs (free) is to be established. However, the administration of ceiling is to be continued.
 - (b) Twine, cordage, ropes and cables (CCCN tariff heading No. 59.04.1-4) and sacks and bags, of a kind used for the packing of goods (CCCN tariff heading No. 62.03), which have so far been exempted from the special treatment for LLDCs, are to be subject to the special treatment, G.e. to be imported without restriction of the ceiling).

^{1&}quot;Specified rate" is to be stipulated by a cabinet order and is in any case to be not more than 6 per cent.

3. Tariff reductions on specific items (47 items)

Tariff reductions on specific items listed below are to be reduced as a market opening measure.
