PORTUGAL - IMPORT SURCHARGE SCHEME

Addendum

The following information has been notified to the secretariat by the Delegation of Portugal.

The Portuguese import surcharge scheme has been maintained in force until 31 December 1984.

Since the last notification in document GATT L/5145/Add.2, some changes were introduced in the Portuguese import surcharge scheme. As set out by Decree-Law No. 103-A/84, of 30 March, the import surcharge was rolled back to 10 per cent from the 30 per cent to which it was raised on 1 February 1983. By Decree-Law No. 304/83, of 28 June, Decree-Law No. 83/84, of 14 March, and Decree-Law No. 103-A/84, of 30 March, some products which are listed in the Annex have been withdrawn from the list of products subject to the 10 per cent surcharge as set out by Decree-Law No. 110/79 and its amendments.

Due to the new customs tariff and the new Portuguese nomenclature of goods for the external trade statistics in force since 1 January 1983, it is impossible to collect data respecting the products under the surcharge scheme as well as their respective rate of coverage by main origin markets.

In that context, the last data available are those shown in the last notification referred to above.
