# GENERALIZED SYSTEM OF PREFERENCES

### Notification by Czechoslovakia

### Addendum

The following communication from the delegation of Czechoslovakia dated 13 August 1984 is circulated for the information of contracting parties.

I wish to inform you that the Decree of the Federal Ministry of Foreign Trade of Czechoslovakia No. 3/1982 of the Collection of Laws on the Exemption from Customs Duties of Goods Imported from and Originating in Developing Countries reproduced in document L/3703/Add.4 was amended by the attached Decree of the Federal Ministry of Foreign Trade of Czechoslovakia No. 40/1984 of the Collection of Laws on the Exemption from Customs Duties of Goods Imported from and Originating in Developing Countries. The Decree entered into force on 10 May 1984.

Through the new legislation the total number of developing countries enjoying preferential treatment has been increased from 116 to 120 countries, of which the number of least developed countries was enlarged to 32 countries. The new legislation has also reduced the number of items excluded from preferential treatment from twenty-four to six.

# Decree No. 40/1984

# of the Federal Ministry of Foreign Trade dated 10 May 1984

changing the Decree of the Federal Ministry of Foreign Trade No. 3/ 1982 on the Exemption from Customs Duties of Goods Imported from and Originating in Developing Countries.

The Federal Ministry of Foreign Trade acting in agreement with the Federal Ministry of Finance and with the Federal Ministry of Foreign Affairs decides under section 44, paragraph 2, of the Customs Law No. 44/1974 of the Collection of Laws:

# Section I

The Decree of the Federal Ministry of Foreign Trade No. 3/1982 of the Collection of Laws on the Exemption from Customs Duties of Goods Imported from and Originated in Developing Countries is amended as follows:
