Addendum

The following communication, dated 12 June 1985 has been received from the Swiss delegation and is circulated for the information of contracting parties.

Further to my letter of 14 May 1985, I have the honour to forward to you herewith the text of the amendment of 25 May 1983 (attached) to Annex 2 to the Ordinance of the Federal Council, dated 26 May 1982, establishing preferential customs duties in favour of developing countries. This text, which reflects the exceptions applied in respect of certain beneficiaries - exceptions that were not entirely carried over into the amendment of 3 December 1984 to the Ordinance - remains in force.
