ROSTER OF NON-GOVERNMENTAL PANELISTS

The CONTRACTING PARTIES decided at their fortieth session that "contracting parties should indicate to the Director-General the names of persons they think qualified to serve as panelists who are not presently affiliated with national administrations but who have a high degree of knowledge of international trade and experience of the GATT" and that "these names should be used to develop a short roster of panelists to be agreed upon by the CONTRACTING PARTIES in consultations with the Director-General" (L/5752).
