REPLIES TO QUESTIONNAIRE ON IMPORT LICENSING PROCEDURES

Finland

Corrigendum

The following notification has been received from the delegation of Finland in response to the questionnaire on import licensing procedures annexed to document L/5640/Rev.3. It updates information previously contained in L/5130/Rev.1.

Page 2, reply no. 3-4, paragraph B: amend the second chapter to read as follows:

"The import régime is also applicable to the import of products enumerated under A from socialist countries with which Finland has concluded agreements on the reciprocal removal of the obstacles to trade, viz. Bulgaria, Czechoslovakia, German Democratic Republic and Poland".

Page 3, reply no. 3-4, paragraph C: amend the text to read as follows:

"Licensing for the administration of bilateral quotas under bilateral trade agreements applies to products from the Union of Soviet Socialist Republics. The import régime also applies to products enumerated under A and B when imported from this country.

The bilateral licensing régime applies to imports from the country above provided that the country of purchase and the country of origin is the Union of Soviet Socialist Republics and that payments are effected as stipulated in the applicable agreement on payment".
