Communication from Egypt, Dated 20 May 1988

In pursuance of paragraph 2 of the Declaration on Trade Measures Taken for Balance-of-Payments Purposes, and paragraph 3 of the Understanding Regarding Notification, Consultation, Dispute Settlement and Surveillance, attached herewith is a list of the import restricted items as it stood on 20 February 1988.

The attached list contains items restricted for balance-of-payments reasons, as well as items restricted for other reasons. The relevant GATT Article is cited for each item in the list, as well as the form of restriction applied.

The form of restriction applied on most of the items contained in the list is "conditional prohibition", i.e. the importation of such items is prohibited unless they fall within one of the following categories: - imports by licensed local manufacturers and assembly lines, imports for the sector of tourism, imports for turn-key projects, imports under the draw-back system.
