NOTIFICATION UNDER PARAGRAPH 3 OF THE UNDERSTANDING REGARDING NOTIFICATION, CONSULTATION, DISPUTE SETTLEMENT AND SURVEILLANCE AND PARAGRAPH 3 OF THE DECLARATION ON TRADE MEASURES TAKEN FOR BALANCE-OF-PAYMENTS PURPOSES

Communication from Yugoslavia, dated 3 June 1988

The Permanent Mission of Yugoslavia has notified the attached information concerning changes in the special charge on imports of certain agriculture and foodstuff products.

In March 1988. Yugoslavia further shortened the list of products subject to the special charge payable on imports

of certain agricultural and foodstuff products by excluding sheep's or lamb's wool, not carded or combed and cotton, not carded or combed (The Decision setting agricultural and foodstuff products subject to special charge-Official Gazette of the SFRY, No 24/88,).

At the same time the products were classified under the Harmonised System. So the special charge is now applied on the following products:
