NOTIFICATION IN PURSUANCE OF PARAGRAPH 3
OF THE UNDERSTANDING REGARDING NOTIFICATION,
CONSULTATION, DISPUTE SETTLEMENT AND SURVEILLANCE

Communication from South Africa

The following communication, dated 23 August 1988, has been received from the Permanent Mission of South Africa.

I have the honour to refer to South Africa's communication in document L/5898 of 31 October 1985, notifying the contracting parties of its decision to introduce a surcharge of 10 per cent ad valorem on certain imports, and to inform you, in terms of paragraph 3 of the Understanding Regarding Notification, Consultation, Dispute Settlement and Surveillance that, due to a further deterioration in South Africa's terms of trade, and in order to safeguard its already depleted monetary reserves from a persistent threat of a further decline, the South African Government has decided to extend temporarily the import surcharge and to amend its rate, as indicated in the attached copy of an announcement issued by the Minister of Finance.¹

By the substitution for Part 4 of Schedule No. 1 of the following:

" PART 4

ANNOTATIONS

SURCHARGE

NOTES

1. The rate of surcharge specified in this Part in respect of any imported goods (excluding goods provided for in Note 7) shall apply to any such goods at the time of entry for home consumption in terms of Schedule No. 1 or 4.
2. The value for surcharge purposes shall be the value for customs duty purposes as defined in section 65(1).
3. Any surcharge payable in terms of this Part in respect of any goods specified therein shall be additional to any customs or excise duty payable in terms of Part 1 or 2 in respect of such goods.
4. Imported goods shall not be declared on separate bills of entry for the purposes of Parts 1, 2 and 4 of this Schedule.
5. Where the tariff heading or subheading under which any goods are classified in Part 1 of this Schedule is expressly quoted in this Part it shall be deemed not to include goods which are not classified under the said tariff heading or subheading.
6. Any reference in this Part to a tariff heading comprising two digits followed by a point and two noughts (for example, 01.00) shall, for the purposes of Note 5 to this Part, be construed as referring to all tariff headings in Part 1 of this Schedule the first two digits of which correspond to the two digits referred to in this Part.
7. Any rate of surcharge specified in this Part in respect of any goods shall not apply to any such goods -
 - (a) which are entered in terms of rebate items 405.04, 405.05, 406.00, 407.00, 408.00, 409.00, 412.02, 412.03, 412.04, 412.07, 412.09, 412.10, 412.11, 412.12, 412.13, 412.15, 412.16, 412.17, 412.24, 460.07/39.19, 470.00, 480.00 and 490.00 of Schedule No. 4,
 - (b) provided for in paragraphs (i) to (iv) of the proviso to section 38(1)(a),
 - (c) imported in such quantities, at such times, for such purposes and subject to such conditions as the Director-General: Trade and Industry, on the recommendation of the Board of Trade and Industry, may allow by specific permit after proof has been furnished that these are capital goods or components -
 - (i) imported by a manufacturer operating at full capacity;
 - (ii) for the establishment of a new industry;
 - (iii) required for technology advance; or
 - (iv) not satisfactorily available locally,
 - (d) cleared in accordance with a permit issued by the Director General: Trade and Industry, on the recommendation of the Board of Trade and Industry, for use in the manufacture, processing, finishing, equipping or packing of goods exclusively for export,
 - (e) being printed books, newspapers, journals and periodicals, imported by post, of a value for duty purposes not exceeding R40 per parcel, and
 - (f) imported in terms of the agreement between the Republic of South Africa and Southern Rhodesia (Zimbabwe) and the agreement between the Republic of South Africa and Malawi.
