### REPLIES TO QUESTIONNAIRE ON IMPORT LICENSING PROCEDURES

#### PERU

#### Supplement

The following communication, dated 7 April 1989 supplements the information contained in the reply by Peru circulated as L/5640/Add.34/Rev.1.

The Permanent Mission of Peru to the International Organizations at Geneva presents its compliments to the GATT secretariat and has the honour to refer to its note GATT/25, of 12 September 1988, transmitting the notification of Peru in reply to the questionnaire on import licensing procedures in Peru, the text of which was reproduced in document L/5640/Add.34/Rev.1.

In this connection, it would be greatly appreciated if the following new sub-paragraph (g) could be added to paragraph 18 of the said document, reading as follows:

- "[18.] Administrative procedures preceding that of prior Import Licensing]:
- (g) The importation of goods and products resulting from ionizing radiations is subject to the prior approval of the Peruvian Nuclear Energy Institute.
