TECHNICAL GROUP ON QUANTITATIVE RESTRICTIONS AND OTHER NON-TARIFF MEASURES

Note on the Meeting of 11 April 1989

1. The Technical Group on Quantitative Restrictions and Other Non-Tariff Measures held its third meeting on 11 April 1989 (GATT/AIR/2743).

2. The Technical Group's terms of reference and the procedures relevant to its work as agreed by the CONTRACTING PARTIES since 1984 are consolidated in document NTM(TG)/W/4).

- 3. The following agenda was adopted:
 - A. Election of chairman
 - B. Continuation of the review of the accuracy and adequacy of the documentation and the grounds on which measures are maintained and their conformity with the General Agreement
 - C. Next meeting
 - D. Report to the Council

A. <u>Election of chairman</u>

4. The Technical Group requested the secretariat to chair the meeting. The meeting was chaired by Mr. P. Williams.

B. <u>Continuation of the review of the accuracy and adequacy of the</u> <u>documentation and the grounds on which measures are maintained and</u> <u>their conformity with the General Agreement</u>

5. The Chairman recalled that the Technical Group had met in September 1988 to carry out its biennial review in accordance with the procedures agreed by the CONTRACTING PARTIES (BISD, 31S/222-223 and 227-228; BISD, 32S/92-94).

6. At that meeting, the Technical Group had noted that more time was required for contracting parties to make their biennial complete notifications of the quantitative restrictions they maintained and for the secretariat subsequently to consolidate these in one document and to up-date its analyses of the basic documentation. The Technical Group, therefore, agreed to meet in April 1989 to resume its review of the accuracy and adequacy of the documentation and the grounds on which measures are maintained and their conformity with the General Agreement (L/6397, paragraph 19).

7. The secretariat had, as requested, consolidated the quantitative restrictions notifications in document NTM/W/6/Rev.5 and up-dated its analyses of the basic documentation in NTM(TG)/W/5. Notifications received since the consolidation in NTM/W/6/Rev.5 had been circulated in Addenda 1 and 2 to that document.

(i) <u>Quantitative restrictions</u>

8. The notifications of quantitative restrictions before the Technical Group consisted of the self-notifications in documents NTM/W/6/Rev.5 and Rev.5/Add.1 and 2, and in AG/FOR/REV/- series, and of reverse notifications in addenda 17-21 of the Inventory of Non-Tariff Measures (Industrial Products), NTM/INV/IV.A, B, C, E, and G.

9. In view of the adoption by some contracting parties of the Harmonized System (HS) Nomenclature, the documents in the NTM/W/6/- series were now in two parts, one in the Customs Co-operation Council Nomenclature (CCCN), one in the HS Nomenclature. This was reflected in the secretariat's analyses, where relevant annexes were also in two parts. The notifications in the AG/FOR/REV/- and NTM/INV/- series, however, remained entirely in the CCCN nomenclature.

The Technical Group noted that there had been some imployement in the 10. self-notifications of quantitative restrictions since it had last met, in terms both of response rate and the compliance with agreed procedures. The tables of the NTM/W/6/- documentation contained detailed information relating to 49 countries (counting the EEC as one). This included 24 notifications (counting the EEC as one) received in response to the request for biennial complete notifications (GATT/AIR/2566) and seven recent notifications under other GATT procedures. Of these seven, six were complete notifications and one complemented a complete notification made to the Technical Group. The 30 countries (counting the EEC as one) for which up-to-date detailed 'information was available accounted for nearly 80 per cent of total contracting parties' trade (excluding intra-EEC trade). Nevertheless, as shown in Annex 3 of NTM(TG)/W/5, the fact remained that, for a significant number of contracting parties, the information available was out-of-date and for some contracting parties no information was available.

11. The Technical Group noted that the notifications had not all given the information called for by the CONTRACTING PARTIES. Annex 3 to NTM(TG)/W/5 (annexed to this document) indicated which notifications had not been made at the tariff-line level and which did not use the agreed list of symbols for the measures maintained. It also noted that contracting parties had not found it possible to indicate the trade effects of measures notified. With respect to the grounds and GATT conformity of measures maintained, the Technical Group <u>noted</u> Annexes 7, 8 and 9 to NTM(TG)/W/5.

12. Since the Technical Group's last meeting, there had been no notifications to the Inventory of Non-Tariff Measures (Industrial Products) and only one in the AG/FOR/REV/- series. This latter was made by a country already covered by a recent complete notification.

The Technical Group agreed that the notification procedures adopted 13. by the CONTRACTING PARTIES (BISD, 31S/222-223 and BISD, 32S/92-93) should be adhered to by all contracting parties. It recommended that those contracting parties that had not up-dated their quantitative restrictions notifications be invited to do so and that those contracting parties whose notifications did not comply with the requirements agreed by the CONTRACTING PARTIES also be invited to amend their notifications accordingly. In particular, it recommended that those contracting parties which had not already done so, make complete notifications of the quantitative restrictions which they maintain as soon as possible, at the tariff-line level. in their current nomenclature or where this was not based on a Customs Co-operation Council nomenclature, the corresponding CCCN or HS headings. It drew attention to Annexes 3 and 9 of NTM(TG)/W/5. It noted that the next complete notification by contracting parties of the quantitative restrictions which they maintain would be due in April 1990.

14. The Technical Group <u>agreed</u> that contracting parties having made notifications of quantitative restrictions in the Integrated Data Base format on magnetic tape by April 1990 would be considered to have fulfilled the reporting requirements laid down by the CONTRACTING PARTIES provided that the notifications contained the information required for the purposes of the Group. It <u>requested</u> the secretariat to make the necessary technical arrangements to enable all quantitative restrictions notifications to be compiled for the purposes of the Technical Group.

(ii) Other Non-Tariff Measures

15. The notifications of other non-tariff measures before the Technical Group consisted of the reverse notifications in Addenda 17-21 of the Inventory of Non-Tariff Measures (Industrial Products) and the self notifications in the AG/FOR/REV/- series.

16. The Technical Group noted that, since its last meeting, no new notifications had been made to the Inventory of Non-Tariff Measures and one only in the AG/FOR/REV/- series. It noted further that little had been

done, in response to the recommendations of the CONTRACTING PARTIES (BISD, 31S/227-228 and BISD, 32S/93), to up-date the Inventory and improve the quality of the information it contained. Many notifications omitted the CCCN or HS headings of the products affected by notified measures; the effects of the measures were not always clearly stated; in few notifications had either notifying or maintaining country referred to relevant GATT provisions. It considered that the little activity in this area might be explained by the fact that notifications had now been called for in the context of the Uruguay Round of Multilateral Trade Negotiations.

17. The Technical Group <u>noted</u> that, under the procedures adopted by the CONTRACTING PARTIES (BISD, 31S/222 and 227-228), the Inventory of Non-Tariff Measures remained open for notifications on a continuous basis. It <u>recommended</u> that those contracting parties whose notifications did not fully comply with the requirements agreed by the CONTRACTING PARTIES consider amending and up-dating their notifications accordingly.

18. The Technical Group <u>noted</u> that a few notifications had been misclassified and <u>requested</u> the secretariat to make the necessary amendments, in consultation with the delegations concerned.

(iii) Secretariat analyses

19. The Technical Group had before it the up-dated analyses by the secretariat of the basic documentation (NTM(TG)/W/5). It noted that it was no longer possible to up-date Annex 14, the compilation by tariff heading of the information in the NTM/W/6/-, NTM/INV/- and AG/FOR/REV/- series because, while some NTM/W/6/- notifications were now being made in HS, all NTM/INV/- and AG/FOR/REV/- notifications remained in CCCN. However, the compilation in Annex 14 had been made as a first step towards an integrated data base. This had, therefore, been largely overtaken by agreement to establish such a data base in GATT.

20. The Technical Group <u>noted</u> that its documentation remained available to other Groups, including the relevant bodies established under the Ministerial Declaration on the Uruguay Round (BISD, 33S/54).

C. <u>Next meeting</u>

(i) <u>Date</u>

21. The Technical Group <u>noted</u> that its next regular meeting would be held in September 1990 to carry out the biennial multilateral review of the accuracy and adequacy of the documentation and the grounds and GATT conformity of measures (BISD, 32S/94).

(ii) Documentation

22. The Technical Group <u>noted</u> that, as an increasing number of contracting parties made their notifications in the HS nomenclature, the size of the NTM/W/6/- documentation would grow very large. It therefore recommended that the secretariat:

- (i) publish as and when, necessary, a list of notifications received and incorporated in the data base;
- (ii) not to issue further compilations of notifications in the NTM/W/6/- documentation, but to make available to contracting parties, as and when requested on paper or computer tape, detailed extracts of the quantitative restrictions data base;

D. <u>Report to the Council</u>

23. The Technical Group requested the secretariat to prepare, in the usual way, a note on the meeting and <u>agreed</u> that this note should be presented as its report to the Council.

ANNEX

QUANTITATIVE RESTRICTIONS

Overview of Information

The following table updates Annex 3 of NTM(TG)/W/5. It summarizes the information available on measures maintained by all contracting parties as at 10 April 1989 (NTM/W/6/Rev.5 and Add.1 and 2).

The information is presented as follows:

- Column 1: the contracting parties applying the restrictions
- Column 2: the date on which the latest notification was made to the GATT
- Column 3: the nature of the information on measures maintained:
 - D detailed (contained in the table of NTM/W/6/Rev.5)
 - G general (contained in the country notes of NTM/W/6/Rev.5)
 - No QRs the contracting party has notified that it does not maintain any quantitative restrictions
 - no information available
- Column 4: whether the detailed notification is made in the Customs Cooperation Council Nomenclature (CCCN) or the Harmonized System (HS)
- Column 5: whether products are identified at the tariff-line level
- Column 5: whether the notification conforms entirely with the revised list of measure symbols (BISD, 32S/108)
- Column 7: existence of quantitative restrictions notifications, against the contracting party concerned, in the Inventory of Non-Tariff Measures (Industrial Products): NTM/INV/IV.A, B, C, E, G
