AUSTRIA - TARIFF REDUCTIONS

The following communication, dated 12 May 1989, has been received from the Permanent Mission of Austria.

At the Ministerial Meeting in Montreal in December 1988 Austria announced its intention to implement an advance reduction of a large number of tariff rates with the main aim of lowering those tariffs which can be considered as still relatively high.

Austria presents in the Annex¹ to this note the list of proposed tariff reductions which will be implemented on 1 January 1990. The circulation of this list and of the explanations given in this note to all participating countries is requested.

Some of the reductions apply to tariff rates not bound in GATT. These rates are underlined.

These reductions will be implemented autonomously and without staging on a most favoured nation basis and will be in force provisionally until 31 December 1991. The provisionally reduced tariff rates do not constitute concessions in the legal GATT sense, consequently any changes will not be subject to the procedures under Article XXVIII or of any other GATT provisions or rules.

The Austrian measure is meant as an advance contribution to the results of the Uruguay Round's multilateral tariff reduction exercise on the basis of a harmonization formula. Austria has always favoured such an approach and continues to co-operate in negotiating the particulars of such a formula.

Austria is prepared to negotiate the inclusion of these tariff reductions in its GATT Schedule XXXII - Austria and will claim full credit for these reductions in the framework of the Uruguay Round's market access negotiations.

Ministers in Montreal agreed on a substantial reduction or elimination of tariffs by all participants. In accordance with these conclusions, Austria intends to conduct consultations with countries benefiting from the autonomous Austrian action and from eventual bindings with a view to achieving equivalent benefits where appropriate. Calculations are under way in Austria to assess the overall cut in the average tariff rate level. Subject to the outcome of this assessment and upon request by other participants Austria is prepared to negotiate further tariff reductions as formulated by Ministers in Montreal. It is evident that the final concessions to be incorporated in GATT Schedule XXXII - Austria will depend on the general outcome of the Uruguay Round.
