HUNGARIAN FOREIGN TRADE STATISTICS

Communication from the Government of Hungary

The following communication, dated 5 June 1989, has been received from the Delegation of Hungary.

With reference to the forthcoming session of the Working Party on Trade with Hungary and to the statistics we have already provided (L/6501), I have the pleasure to enclose additional statistical information relating to the structural pattern of the total Hungarian exports and imports by principal commodity groups according to SITC classification. When providing this additional breakdown we have taken into account a request made at the last session of the Hungarian Working Party.

Relating to all statistical information the following should be noted:

- The geographical distribution of the Hungarian exports and imports is provided on the basis of country of destination and origin, respectively;
- Export data are calculated on FOB, import data on CIF basis;
- The Hungarian Forint/US Dollar trade weighted average exchange rates were the following:

1985 - export: 49,63

- import: 50,31

1986 - export: 45,89

- import: 45,90

1987 - export: 47,03

- import: 46,99

1989 - export: 50,76

- import: 50,56
