The following notification updates the information appearing in document L/6111/Add.22.

# 1. MEASURES FOR RICE, WHEAT AND BARLEY

#### I.(c) Amount of deficit

In fiscal year 1987, the deficit in the control account of rice, wheat and barley under the Food Control Special Account was ¥ 283,726 million (excluding the deficit incurred from the surplus disposal of rice).

## 2. MEASURES FOR SWEET AND WHITE POTATOES

#### I.(c) Amount of deficit

In fiscal year 1987 there was no financial payment.

#### II. Effect of measures (2nd paragraph)

While the production of potato starch declined almost by half from 800,000 tons in 1965 to 430,000 tons (average from 1985 to 1987), the import of starch steadily increased and remained stable at the level of around 175,000 tons in 1986 and 1987.

#### 3. MEASURES FOR SUGAR

#### I.(c) Amount of subsidy

In fiscal year 1988, ¥ 17,414 million was financed as a subsidy to the Japan Raw Silk and Sugar Price Stabilization Agency in order to support the price of the domestically produced sugar.

#### II. Effect of measures (Last sentence)

The domestic production of sugar was 950,000 tons (for "89,000 tons" in L/6111/Add.2 read "890,000 tons") on the average from 1985 to 1987, and the import was 1,860,000 tons on the average for the same period. (The figures are crude sugar basis of a polarization of 96° in calendar year).

#### 4. MEASURES FOR SOYABEAN AND RAPESEED

#### I.(c) Amount of subsidy

In fiscal year 1987, ¥ 32,623 million was paid for producers of soyabeans and ¥ 161 million for those of rapeseed. the amount of subsidy per unit (60 kg.) was ¥ 12,610 for soyabeans and ¥ 8,774 for rapeseed.

#### 7. MEASURES FOR BOVINE MEAT AND PORK

#### I.(b) Incidence (Last paragraph)

In connection with these price stabilization measures, the Livestock Industry Promotion Corporation conducts the purchase and sale operations of the most of imported bovine meat and thereby stabilizing the demand and supply as well as the price of bovine meat. The above system, however, is expected to be terminated on 1 April 1991, with the elimination of import restrictions in respect of bovine meat.

#### I.(c) Amount of deficit

Management costs of this price stabilization system are borne by benefits derived from the operation of the funds of the Corporation. In fiscal year 1987 the amount of the fund to the Corporation was ¥ 98 million.

# 10. OTHER MEASURES BASED ON TEMPORARY LAW ON BUSINESS CONVERSION AND ADJUSTMENT MEASURES FOR SMALL AND MEDIUM ENTERPRISES

Measures listed under this heading, i.o. special treatment in regard to the Small and Medium Enterprises Credit Insurance Law and rescheduling of loans used for equipment modernization, were abolished on 31 March 1988.
