SCHEDULE LXXXIV - BOLIVIA

Bolivia agrees to bind the ad valorem rate of duty on the tariff lines contained in its import tariff schedule at the uniform rate of 40 per cent. For the items contained in list A below, it is agreed that, should the Commission of the Andean Pact require and Bolivia actually implement the Common Minimum External Tariff, the 40 per cent binding would be suspended for at most three years with respect to these items, with the rates indicated in List A below being applied during this interim period. It is further agreed that the relevant provisions of Article XXVIII with respect to these items would also be suspended for the same three-year period, during which Bolivia would undertake negotiations within the Andean Group, pursuant to Article 156 of Bolivian Supreme Decree 21660 of 10 July 1987, in order to restore the bindings for these items in line with its GATT obligations. At the end of this three-year suspension, Bolivia would undertake negotiations required under the relevant provisions of the GATT to resolve the remaining problems and the six-month period referenced in GATT Article XXVIII:3(a) would be deemed to begin for the original bindings on the items in List A. This agreement in no way prejudices the parties' rights and obligations under other provisions of the General Agreement.

LISTE LXXXIV - BOLIVIE

La Bolivie accepte de consolider au taux uniforme de 40 pour cent les droits ad valorem appliqués aux lignes tarifaires figurant dans son tarif douanier d'importation. En ce qui concerne les positions reprises dans la liste A ci-après, il est décidé que, si la Commission du Pacte andin l'exige et si la Bolivie applique effectivement le tarif extérieur commun minimum, la consolidation à 40 pour cent sera suspendue à l'égard de ces positions pour une période de trois ans au plus, durant laquelle les taux indiqués dans ladite liste seront en vigueur. Il est en outre décidé de suspendre l'application des dispositions pertinentes de l'article XXVIII à ces positions pour la même période triennale, pendant laquelle la Bolivie engagera des négociations avec le Groupe andin, conformément à l'article 156 du Décret suprême 21660 du 10 juillet 1987, afin de rétablir la consolidation des droits sur ces positions comme l'Accord général lui en fait obligation. Au terme de cette période de suspension, la Bolivie engagera les négociations prévues par les dispositions pertinentes de l'Accord général en vue de résoudre les problèmes qui subsistent et le délai de six mois mentionné à l'article XXVIII:3 a) de l'Accord général commencera à courir pour les consolidations primitivement consenties à l'égard des positions de la liste A. Le présent accord ne préjuge en rien des droits et obligations des parties au titre des autres dispositions de l'Accord général.

LISTA LXXXIV - BOLIVIA

Bolivia acuerda consolidar el derecho ad valorem aplicado a las líneas arancelarias contenidas en su Arancel de Importaciones al tipo uniforme del 40 por ciento. Por lo que se refiere a las partidas que figuran en la lista A infra, se acuerda que, si la Comisión del Pacto Andino lo prescribe y Bolivia pone efectivamente en aplicación el Arancel Externo Común Mínimo, la consolidación al 40 por ciento quedará en suspenso con respecto a dichas partidas por un plazo máximo de tres años, período transitorio éste durante el cual se aplicarán los tipos indicados en la lista A infra. Se acuerda además que también quedarán en suspenso las disposiciones pertinentes del artículo XXVIII respecto de dichas partidas por ese mismo plazo de tres años, durante el cual Bolivia celebrará negociaciones en el seno del Grupo Andino, en conformidad con el artículo 156 del Decreto Supremo de Bolivia 21660, de 10 de julio de 1987, con objeto de restablecer las consolidaciones en lo tocante a dichas partidas en armonía con sus obligaciones dimanantes del Acuerdo General. Al llegar a término esa suspensión por tres años, Bolivia entablará las negociaciones requeridas en virtud de las disposiciones pertinentes del Acuerdo General a fin de resolver los problemas pendientes, y se considerará iniciado el plazo de seis meses a que se refiere el párrafo 3 a) del artículo XXVIII del Acuerdo General en lo que respecta a las consolidaciones originales correspondientes a las partidas incluidas en la lista A. El presente acuerdo no prejuzga en absoluto los derechos y obligaciones de las partes en virtud de otras disposiciones del Acuerdo General.
