SCHEDULE LXXXV - COSTA RICA

The Government of Costa Rica will bind the ad valorem rate of duty on the tariff lines contained in its import tariff at a uniform maximum rate of 60 per cent, within one year from the date of its accession to the General Agreement, and within three years from that date, will reduce the maximum ad valorem rate to 55 per cent, except in respect of the items listed in Annex A. Initial negotiating rights are set out in Annexes A and B.

NOTES

1. The schedule is authentic in the Spanish language.
2. The concession applies only to the eight-digit items. The titles of headings are included to facilitate description.
3. Items followed by the figure three in brackets (3) are exempt from licensing or other quantitative restrictions and from duties and charges not consistent with the provisions of Articles III and VIII. This binding will come into effect within four years from the date of Costa Rica's accession to the GATT. It is understood that these concessions shall not affect Costa Rica's rights under the General Agreement or other mechanisms of the GATT system. If, as a result of the exercise of these rights, the concessions are eroded, Costa Rica shall conduct the necessary negotiations to compensate the affected contracting parties.
4. Application of concessions to the items followed by the figure four in brackets (4) is subject to the approval of the Central American Tariff Council. If such approval has not been obtained by the time the bindings come into affect, Costa Rica shall conduct the necessary negotiations in accordance with the relevant provisions of the General Agreement.
