FINLAND

The Permanent Mission of Finland presents its compliments to the secretariat of the General Agreement on Tariffs and Trade and has the honour, with reference to GATT/AIR/2822 dated 15 November 1989, to notify that Finland does not apply any discriminatory prohibitions or quantitative restrictions to imports from Romania.

HUNGARY

With reference to GATT/AIR/2882. I have the honour to inform you that Hungary does not apply any discriminatory prohibitions or restrictions to imports from Romania.

SWEDEN

With reference to GATT/AIR/2882, please find enclosed Sweden's notification pursuant to paragraph 3(b) of Romania's Protocol of Accession.
