DECLARATION ON TRADE MEASURES TAKEN
FOR BALANCE-OF-PAYMENTS PURPOSES¹

Communication from the Philippines

The delegation of the Philippines, in a communication dated 25 July 1990, has notified the following Central Bank Circulars containing import liberalization measures taken by the Philippines since 1987:²

1. Circular Nos. 1128, 1149, 1150, 1161, 1167 and 1174, issued between 9 January 1987 and 25 April 1988. These Circulars are pertinent to the Philippines' commitments set out in document BOP/269/Add.2.
2. Circular Nos. 1192, 1195, 1205, 1210, 1212, 1219 and 1231, issued between 22 December 1988 and 27 February 1990.

Pursuant to the provisions of Monetary Board Resolution No. 1182 dated 23 December 1986 and in line with the recommendation of the Ministry of Trade and Industry and Board of Investments, the Monetary Board has approved the following schedule for the liberalization of the importation of the items detailed in the attached Annexes:

<u>Schedule date</u>	<u>Annex</u>
1. December 1986	1
2. End June 1987	2
3. End October 1987	3
4. End December 1987	4
5. End April 1988	5

Accordingly, importation of the NEC-9 items listed in Annex 1 is now allowed through letters of credit without prior approval of the Central Bank.

The list of commodities falling under the above-cited schedule dates may be changed, subject to the results of public hearings that will be conducted jointly by the Ministry of Trade and Industry and the National Economic and Development Authority within the next thirty days, provided that any change in the schedule shall be for an acceleration and in no case for a deferment of liberalization.

It is understood that existing clearances/permits required from concerned government agencies other than those listed in the Annexes shall continue to be obtained in accordance with existing laws, PDs, LOIs and similar issuances.
