EXPLANATORY NOTES

1. Under Article 55 of Law No. 3,244/57, Brazil's imports are, in principle, liberalized and are therefore not subject to prior licensing.¹ Nevertheless, for purposes of supervising the classification, specifications and prices of goods for application of the ad valorem duty rates and for verifying the use made of foreign exchange purchased on the foreign exchange market, imports are the subject of certificates (guias) which are issued by CACEX.

2. Brazilian imports are divided into three categories; imports for which a licence is not required, imports for which a licence is required and prohibited imports. The licensing system is not intended to restrict the quantity or the value of imports.

3. A licence is required before dispatch from abroad, for goods imported under special conditions, in particular goods which are to benefit from exemption or reduction of duties for which are imported by means of external financing for a period exceeding 180 days or which are purchased by any Brazilian official body.

4. An import licence must be produced before or after dispatch of the goods from abroad, but before customs clearance, in particular in the case of goods the import of which is subject to the regulations of the competent authorities. These goods are designated by the symbol L in the list below.

5. Imports of goods from Cuba and Southern Rhodesia are prohibited.

6. Brazil has trade or payments agreements with Bulgaria, the Federal Republic of Germany, Greece, Hungary, Iceland, Israel, Poland, Romania and Yugoslavia. Brazil is a member of the Latin American Free Trade Association.

¹For purposes of exchange control, Article 48 of Law No. 3,244/57 provides the possibility of classifying imported goods in two categories (general and special), imports in the latter category being subject to permit. This restriction was, however, applied only until 1 March 1967; from that date, accordance with resolution No. 41 of 22 November 1966 of the Central Bank of Brazil, imports of the products which had until then made up the special category were brought under the same régime as those in the general category i.e. exempt from licensing.
