EXPLANATORY NOTES

1. The products subject to various restrictions are listed in the order of their BTN numbers.

2. Interested countries:

Canada: items 01.05, 10.01, 10.06, 11.01, 15.07, 15.08 and 15.12 of the BTN.

United States: all products listed.

3. Type of restrictions: the following symbols are used in the list:

P: products the importation of which is temporarily prohibited.

L: products subject to a licensing system.

Article 15 of the Agriculture Act provides that "the Ministry of Agriculture shall be responsible for regulating supplies of food stuffs and likewise imports and exports of agricultural products and inputs in general". In pursuance of this article, the Government had issued a supreme decree to regulate imports of agricultural products consistently with the foreign exchange availabilities allocated for this purpose by the Ministry of Economic Affairs and Finance. It is laid down that imports of agricultural products shall be subject to licensing by the Ministry of Agriculture in appropriate cases.<sup>1</sup>

ST: State trading.

The State Agricultural Service has sole authority to make imports of edible fruit, vegetables, plants, roots and tubers.

BQ: Bilateral quota.

4. The licensing system applies to agricultural products from any country with which Peru maintains trade relations, preference being given to products which have been the subject of negotiations under the Montevideo Charter or the Cartagena Agreement.

5. Unless otherwise indicated, the remarks have been taken from reference documents.
