EXPLANATORY NOTES

- 1. The products subject to prior import licensing are indicated in the attached list, in the order of the corresponding CCCN tariff headings.
- 2. The prior import licence is an essential requirement that must be fulfilled for the import of products under restriction.
- 3. Type of restrictions the following symbols are used in the list:

P: Products the import of which is prohibited

L: Products subject to licensing

ST: State trading

- 4. The Peruvian State, having responsibility for ensuring normal domestic supply, has established a number of public agencies with exclusive rights in the marketing of certain basic products: wheat, maize, rice, grain sorghum, soyabeans, soyabean oil, potatoes; petroleum and certain hydrocarbon derivatives; the following fertilizers: urea, guano and other natural fertilizers; ammonium, calcium and magnesium nitrates, potassium chloride, potassium sulphate, ammonium phosphates, calcium hydrogen sulphate, triple superphosphates; pearls, precious and semi-precious stones and precious metals, unworked; salt.
- 5. The comments in respect of products subject to prior licensing, those which may be imported exclusively by the public sector and products the import of which is prohibited are indicated in the annex.
