 - D import licence required.
 - effective 20 June 1968, the Federal Secretariat for Foreign Trade is issuing special accordances for the importation of these goods these accordances will complement, not replace, the existing system for obtaining foreign exchange. Thus after getting the accordance, the importer must then meet the requirements of the foreign exchange category governing the item. Issuance of the accordance does not constitute permission to buy foreign exchange.
