COMMUNICATION FROM THE DELEGATION OF SPAIN

The following communication, dated 4 August 1978, has been received from the delegation of Spain.

On the instructions from my Government, I have the honour to inform you as follows.

By Resolution of 20 July 1978, the General Directorate of Tariff Policy and Imports of my country's Ministry of Trade and Tourism has given instructions that the regime of free importation be applied in respect of the goods included in the following list and which previously were subject to global quota or State trading or to a regime other than that of liberalized trade, global quota or State trading:

My country's authorities consider that this liberalization of the importation of numerous products formerly subject to quotas or State trading constitutes an important contribution by Spain in the area of non-tariff barriers and that their removal can be the subject of compensation in the context of the multilateral trade negotiations now proceeding in GATT.

The total volume of imports affected by this measure involves more than Ptas 45,000 million annually and can be expected to increase considerably following the liberalization of these imports.

Therefore, the Spanish authorities consider this liberalization, as they did in the case of the liberalization of 16 January 1978, reported in document MTN/NTM/W/142, as constituting a contribution to the multilateral trade negotiations that may be the subject of compensation. In this connexion, this liberalization will shortly be communicated directly to the

principal parties that will benefit therefrom, and to all those parties which, in the course of the negotiations, have requested the removal of these barriers.

Furthermore and simultaneously, under Royal Decree 1780/1978 of the same date, a conjunctural and temporary linear reduction has been made in all tariff duties on the products covered by Chapters 25 to 99 inclusive, with the exception of Chapter 55, of the Spanish tariff.

This involves a reduction of 20 per cent of all duties on the portion in excess of 10 per cent ad valorem, or in the case of specific duties, a reduction of 10 per cent of such duties.

As this reduction is temporary and conjunctural, it may in no case serve as a basis of negotiation for the removal of tariff barriers.
