TROPICAL PRODUCTS

SUBMISSION BY ASEAN COUNTRIES

The following statement was made by the ASEAN delegations at the third meeting of the Negotiating Group on Tropical Products on 3 July 1987 with the request that it be circulated to members of the Group.

At the second meeting of the Negotiating Group on Tropical Products (11 May 1987), the ASEAN delegations reiterated that the ASEAN harmonization proposal was still on the table. It still is and we are now circulating it as a written proposal, albeit with a further expansion to cover non-tariff measures as well.

To recap the original proposal, ASEAN seeks the alignment of tariffs on tropical products in the developed contracting parties to the lowest level prevailing among them. As to the question of non-tariff measures, we seek non-tariff measures-free treatment. This proposal is in line with the Ministerial Declaration on tropical products which states that there shall be the fullest liberalization of trade in tropical products including in their processed and semi-processed forms and shall cover both tariff and non-tariff measures. We have heard time and again from the developed contracting parties that they are all committed to provide special attention to this issue, both in its implementation and timing and we are requesting the developed contracting parties to translate that political commitment into concrete action.

Positive movement in this negotiating group will go a long way into bringing about the much-needed confidence necessary to ensure the eventual success of the Uruguay Round. It is extremely vital for the developing countries to gain that confidence and allay the fears once and for all that there is nothing in store for them in this Round. Now it is the time to prove to us that such fears are unfounded and the only way to do it is to take that concrete action.

We had suggested, at the last meeting, of a possible way to work on the proposal. There had been some misunderstanding on what we said then and so we wish to repeat the suggestion:

GATT SECRETARIAT UR-87-0200 - First, participants will submit to the secretariat a list of specific tropical products of export interest to them. (The submission by participants of such lists should not be construed to be the traditional request lists).

- Second, the lists can then be compiled by the secretariat and the products therein be classified according to the seven product groups.

- Third, the secretariat can then provide the updated data on tariffs and non-tariff measures applied to these products.

- Fourth, once the complete data is available, the Negotiating Group will examine on a product-by-product basis, the height, spread and concentration of tariff rates applied to these products. Developed contracting parties will then lower their tariffs to the lowest tariff prevailing amongst them and at the same time to completely remove all the NTMs being applied to the products in question.

In line with our suggestion, ASEAN is also making available a tentative, first list of specific tropical products of export interest to ASEAN. Since this is a tentative list, we reserve our right to revise it further.

ASEAN Harmonization Proposal

In line with the Ministerial Declaration to have the fullest liberalization of tariffs, and non-tariff measures on tropical products, ASEAN proposes the following negotiating modalities:

Tariffs

ASEAN seeks the alignment of tariffs on tropical products to the lowest prevailing tariffs among the developed contracting parties.

Non-Tariff Measures

ASEAN requests non-tariff measures-free treatment on tropical products in the developed contracting parties.
