#### TROPICAL PRODUCTS

#### Indicative List Submitted by Australia

The following communication dated 31 March 1988 has been received from Australia with the request that it be circulated to the members of the Group.

#### Proposal by Australia

In accordance with the importance and priority that Ministers at Punta-del-Este attached to negotiations on tropical products, Australia submits the following proposal.

#### Scope of Negotiations

Negotiations should cover the following seven product groups (MTN.GNG/NG6/W/5) with no exceptions:

- . Tropical Beverage items
- . Spices, flowers, plants etc
- . Certain cilseeds, vegetable cils and cilcakes
- . Tobacco, rice and tropical roots
- . Tropical fruits and nuts
- . Tropical wood and rubber
- . Jute and hard fibres

All countries should bring their trade distorting measures which affect the above listed tropical products to the negotiating table.

### Negotiating Approach

Australia supports a formula or other systematic approach to the negotiations on Tropical Products. In order to fulfil the Negotiating Mandate of "the fullest liberalisation of trade in tropical products", Australia proposes that all participating countries:

- (1) Negotiate the phased elimination within ten years, preferably on an accelerated basis, of all trade protective barriers on all tropical products up to and including their primary processed stage.
- (2) Negotiate reductions in overall levels of protection for other tropical products, preferably as part of a formula approach covering both tariff and non tariff measures including subsidies which have a trade effect.
- (3) Negotiate tariff bindings on all tropical products.

Australia has some tropical product export interests which it is proposed to pursue as part of these negotiations. Details are included in the attachment. -
