The following communication dated 10 June 1988 has been received from the delegation of Uruguay with the request that it be circulated to the members of the Group.

The Permanent Mission of Uruguay to GATT presents its compliments to the GATT secretariat and has the pleasure to inform it that in the framework of the procedure adopted by the Negotiating Group on Tropical Products on 28 January 1988, the delegation of Uruguay submits herewith a preliminary indicative list of products of particular interest for Uruguay.

It is pointed out that this indicative list contains certain products not included in the seven product groups selected for the work of the Negotiating Group, in view of the understanding agreed upon by the Negotiating Group (MTN.GNG/NG6/6) that these product groups do not constitute a definition of tropical products nor an exhaustive listing and that other products might be included as negotiations proceed.

The delegation of Uruguay wishes to make it quite clear that it reserves the right throughout the negotiating process to modify, amend, expand or withdraw all or part of the attached list.
