**Indicative List Submitted by Tanzania**

  3. The respective indicative list is submitted without prejudice to Tanzania's position with regard to techniques and modalities to be agreed upon in the negotiations.
  4. The delegation of Tanzania reserves the right, throughout the negotiating process, to modify or amend the indicative list.
