Indicative Lists Submitted by Nigeria

The following communication dated 23 June 1988 received from Nigeria is circulated to all participants. The communication contains a common indicative list addressed to Australia, Austria, Canada, Finland, Japan, New Zealand, Norway, Sweden, Switzerland and the United States.

The attached list of tropical products of export interest to Nigeria is addressed to Australia, Austria, Canada, Finland, Japan, New Zealand, Norway, Sweden, Switzerland and the United States. It is in no way exhaustive and this delegation reserves its rights to add, subtract or modify it, when and if necessary. Nigeria wishes to witness in the course of the Uruguay Round, the binding at zero level, of all tariffs on all tropical products by developed countries. Nigeria also proposes for the immediate elimination of all non-tariff measures such as quantitative restrictions, global quotas, internal taxes and sanitary regulations on these products.

2. In addition, developing countries' contribution should in the opinion of this delegation, be seen not in terms of sectoral reciprocity but in line with the global balance of the Uruguay Round, taking into consideration that their stakes are high in this sector. Nigeria similarly reiterates its conviction on the rigorous use of Part IV of the General Agreement, the "Enabling Clause", as well as relevant sections of the Punta del Este Declaration as guiding references to negotiations in this sector.
