Indicative Lists Submitted by Pakistan

The following communication dated 30 June 1988 received from the delegation of Pakistan is circulated to all participants. The communication contains an indicative list addressed to Australia, Austria, Canada, EEC, Finland, Japan, New Zealand, Norway, Sweden, Switzerland and the United States.

Attached is a preliminary indicative list of products of particular interest to Pakistan. The list is addressed to Australia, Austria, Canada, the European Economic Community, Finland, Japan, New Zealand, Norway, Sweden, Switzerland and the United States; under the procedures adopted by the Negotiating Group on Tropical Products on 29 January 1988. This submission is further to the joint submission of an initial list of products made by Pakistan alongwith other countries, contained in Document MTN.GNG/NG6/W/8 dated 3 July 1987.

The purpose of this submission is to seek the fullest liberalization of trade in tropical products including in their processed and semi-processed forms, covering tariff and all non-tariff measures.

The Government of Pakistan reserves the right to modify, expand or withdraw all or any part of the content of the present communication.
