Regulations on non-tariff measures

With the exception of headings 40.12 (pharmaceutical articles of rubber), 40.13 (articles of apparel of rubber), 40.16 (articles of hardened rubber), 44.20 (wooden frames), 44.21 (wooden packing cases and packings), 44.24 (household utensils of wood), 44.27 (articles of marquetry), 57.10 (woven fabrics of jute) and 57.11 (woven fabrics of other vegetable textile fibres), which are subject to prior examination by the Ministry of Industry and Foreign Trade, all the other products are covered by the automatic import-licensing system.
