## ROLLBACK

## Notification

The following notification, dated 12 October 1990, has been received from the Permanent Mission of the Republic of Korea.

Pursuant to the commitment on rollback made by Ministers at Punta del Este and also to the agreement reached in the 5 July meeting of the Surveillance Body on the provision of further information to the TNC, the Korean government is communicating to the Surveillance Body its trade liberalization measures taken since inception of the rollback commitment as shown in the attachment.

This communication is made without prejudice to the question of consistency of the measures listed in the attachment with the General Agreement.

## A. <u>Autonomous Import Liberalization</u>

- 1. Korea has been implementing voluntarily ambitious liberalization programmes from the early 1980s. This process has been accelerated since 1985 and the Korean government announced two sets of three-year liberalization programmes for the period 1986-1991.
- 2. As a result of these two programmes a total of 1,004 products have been liberalized as of January 1990:

## B. Elimination of Import Surveillance System

3. On 31 December 1988, Korea voluntarily eliminated its import surveillance system, which had been in place since 1977. The system was similar in purpose to the Safeguards mechanism provided in Article XIX of the General Agreement.

## C. Improvement of Import Procedures under Special Laws

- 4. Since 1988, Korea has substantially improved import procedures under its special laws. The purpose of these laws is not to restrict import quantities but to regulate import procedures with a view to maintaining quality levels, ensuring safety and health standards, and protecting the environment.
- 5. Key features of these improvements are as follows:
  - (a) Industrial Goods Quality Control Act:
    - Introduction of nine internationally-acknowledged standards (CSA, UL, JIS, etc.).
  - (b) Grain Management Act and Animal Feed Management Act:
    - Thirty-one items which required import recommendation were liberalized.
  - (c) Pharmaceuticals Act:
    - The import recommendation system applied to around 180 items was substituted with a reporting system.

## D. <u>Implementation of Panel Reports on Korea's Beef Import Restrictions</u>

- 6. In accordance with recommendations in the Panel Reports (L/6503, L/6504 and L/6505), Korea held consultations with the three complainants and reached agreements in April, May and July 1990.
- 7. The agreements, which, among other things, set forth Korea's undertakings concerning its remaining import restrictions on beef, and certain market access measures, were reported to the CONTRACTING PARTIES on 9 July 1990 (for details, see L/6697).

- meat of turkeys, meat and edible offal of other poultry, lupulin, frozen top shells, dried cod, tomato sauces, etc.

 synthetic filament tow of polyester, polyesters of special section face, etc.
