COMMUNICATION FROM THE CZECH REPUBLIC

Draft Schedule of the Czech Republic Concerning
Initial Commitments on Trade in Services

The following communication is circulated at the request of the Czech Republic to the members of the Group of Negotiations on Services.

This Draft Schedule presented by the Czech Republic is based on the draft text for a General Agreement on Trade in Services (GATS), as contained in the revised text of the Services Agreement, dated 29 October 1993.

This Draft Schedule is presented in the expectation of submitting corresponding schedules by other participants in the negotiations and it reflects the bilateral negotiations on initial commitments that the Czech Republic has conducted. The final outcome of the negotiations will be evaluated in the light of the quality and number of offers by other participants of interest to the Czech Republic, the scope and economic value of MFN exemptions sought by other participants and the final content of the GATS and its Annexes. The content of the Draft Schedule is conditional and the Czech Republic reserves its right to modify, extend or reduce it, as well as to make technical changes, correct omissions and inaccuracies, at any time prior to the conclusion of the negotiations.

Since 1989 the Czech Republic has, in the process of economic transition, liberalized substantially its trade in services and thus has contributed to the achievement of progressive higher levels of liberalization of world trade in services. Being a country in economic transition, the Czech Republic has to give due respect to the policy objectives and economic needs of this transition and can, therefore, accept negotiated specific commitments corresponding to this special economic situation and needs. In this context the Czech Republic expects that there will be effective application of commitments set out in paragraph 1 of the Substantive Guidelines for the negotiations of Initial Commitments during the Uruguay Round (tabled as Attachment to the draft GATS) under which these negotiations shall have regard to the situation of countries in economic transition.

In most sectors, the offer constitutes a binding of the regime currently in force and in certain sectors (transportation) the Czech Republic is offering a roll back of existing restrictions.

The Czech Republic does not undertake commitments in areas, which are not directly related to trade in services, like the privatization process.

The Czech Republic has in its legislation certain measures making access to its market in certain sectors dependent on reciprocal possibilities in the markets of other countries. The Czech Republic has not at this stage requested any MFN exemptions for the activities covered by these reciprocity measures. The final decision to maintain this approach will depend on the overall and sectorial balance of commitments and the assumption by others of level of commitment on an MFN basis.

The classification of the sectors is based on the documents MTN.GNS/W/120 and on the 1991 "Provisional Central Product Classification" (CPC) of the United Nations, with some limited variations.

FINANCIAL SERVICES

Measures applicable to all sectors in financial services:

1. Commitments in this Chapter are based on the Agreement on Trade in Services, the Annex on Financial Services and the Understanding on Commitments in Financial Services.
2. Market access commitments with respect to the "cross border supply" and "consumption abroad" are bound to the extent of the obligations in para 3 and 4 of Market Access of the Understanding subject to limitations listed below in individual sectors.
3. The purchase or acquisition of financial services by public entities of the Czech Republic is governed in this schedule by Article XIII of the Agreement. Consequently, obligations under Articles II., XVI. and XVII of GATS do not apply to such purchases and acquisitions.
4. The admission to the market of new financial services and instruments may be subject to the existence of, and consistency with a regulatory framework aimed at achieving the objectives indicated in Article 2.1 of the Annex on the Financial Services.
5. The commitments on presence of natural persons are bound according to the general limitations applicable to all sectors in this schedule (Part I).
6. Otherwise, the commitments in this Chapter are subject to the general conditions or limitations applicable to all sectors in this schedule.
7. In sectors specified below the Czech Republic undertakes specific commitments subject to conditions, limitations and qualifications as listed below:
