Final List of m.f.n. Exemptions of Colombia

Revision

The following communication is circulated at the request of Colombia to the members of the Group of Negotiations on Services.

Colombia presents below its final list of m.f.n. exemptions set out in accordance with the Annex on Article II Exemptions of the General Agreement on Trade in Services (GATS) in document MTN/FA of 13 December 1993.

In the light of the commitments and agreements contained in the Ministerial Decision on Financial Services and the second Annex on Financial Services, Colombia's final list does not include any exemption based on the principle of reciprocity for the application of its initial commitments in the financial services sector. The inclusion of such an exemption will depend on the effective access given to suppliers of financial services established in Colombia in markets of interest to them.

In view of the Chairman's Statement on issues relating to the scope of the General Agreement on Trade in Services, Colombia does not make any m.f.n. commitments concerning measures related to social security, judicial and administrative assistance among public authorities and the settlement of disputes pursuant to bilateral investment protection agreements.

In keeping with its position during the Uruguay Round negotiations, the exemptions requested by Colombia represent the minimum necessary to protect the international commitments that are incompatible with m.f.n. treatment, thus departing as little as possible from this key principle of the GATS.
