ROSTER OF NON-GOVERNMENTAL PANELISTS

1. At their Fortieth Session in November 1984, the CONTRACTING PARTIES decided that, on a trial basis and for a period of one year, "contracting parties should indicate to the Director-General the names of persons they think qualified to serve as panelists who are not presently affiliated with national administrations but who have a high degree of knowledge of international trade and experience of the GATT" and that "these names should be used to develop a short roster of panelists to be agreed upon by the CONTRACTING PARTIES in consultations with the Director-General" (BISD 31S/9).
2. The first roster was agreed upon by the Council at its meeting in November 1985 (L/5906). The Council agreed at its meeting in November 1986 to extend the roster for an additional year, i.e., until November 1987. At its meeting in November 1987, the Council agreed to extend the roster for a further year, with some amendments (L/6269). At their Session in November 1988, the CONTRACTING PARTIES decided to extend the roster for an additional year and approved one additional nomination (L/6425). At its meeting in November 1989, the Council agreed to extend the roster for a further year, as set out in C/W/615 as amended.
3. At its meeting in November 1990, the Council agreed to extend the roster, with an additional nomination, provisionally for a further period until the conclusion of the Uruguay Round negotiations on dispute settlement rules and procedures (L/6763).
4. The roster, as amended by the Council and the CONTRACTING PARTIES since November 1990, is reproduced hereunder. At its meeting on 21 June 1994, the Council will consider the extension of this roster, with any amendments, until the entry into force of the Understanding on Rules and Procedures Governing the Settlement of Disputes contained in Annex II of the Agreement establishing the World Trade Organization.
